CONTRACT FOR COMPETITIVE SPORT CHEER (CSC – STUNT) OFFICIALS

- Officials fees will be paid by the following (please indicate):
 - On-site with check/cash direct to official (Assigning Fees will be paid separately to CASOA via Check)**
 - Through ArbiterSports/RefPay (Assigning Fees will be paid separately to CASOA via Check)**
 - Check sent during/completion of season to official (Assigning Fees will be paid separately to CASOA via Check)**
 - To CASOA and officials to be paid out by CASOA; invoice is required to league/host school(s)**

Official fees are as follows:

- Regular Season – \$45 per official per game (assigning fee not included in this amount)
- Post Season – rate determined by league/section
- Tournaments (5 or more games same date) – rate determined by league/section or \$35 per official per game

Certified officials provided by CASOA will render officiating services for the games scheduled for the **2021** season in with three (3) officials for regular season (league and non-league) games and four (4) officials for post season (playoffs, sections, and championship) games upon availability. CASOA will contact the league contact if the adequate number of officials are unavailable; two (2) scoring officials are allowed upon approval. League/host school will pay officials the amount stated above for services provided.

- Assigning fees are **\$5 per game – applicable to leagues/host schools paying Assigning Fees to CASOA. These fees are separate from Officials Fees.**

League/host school is responsible for the assigning fee per game. The obligation of the school ceases if the official ceases to be a certified official or if the game is cancelled prior to 48 hours of game time because of circumstances deemed acceptable by the CASOA. All officials and assigning fees are still due in case of forfeit or no show of any team.

- CASOA will provide officials located within a fifty (50) mile radius. If any officials are not available within the allotted area, CASOA will notify league/school and games may need to be rescheduled (please indicate):
 - mileage pay will not be allotted to officials**
 - mileage pay will be allotted to officials traveling further than fifty (50) miles and given the standard mileage rate starting after the first fifty (50) miles**

- If there is a change in the league representative/schools, the contract is valid only if and when the incoming league representative/school has been notified of the existing contract and has sanctioned it or has failed to inform the officials of cancellation within one week after notification.
- If the league/school fails to fulfill the obligation of any part of the contract, the remainder of the contract shall not be binding, and officials will not be provided by CASOA for any future games, contests, and activities until obligations have been met.
- Services provided by the officials are as an independent contractor and not an employee of CASOA, or the school, or organization. This contract is valid for the full season listed above and photocopies will be treated as originals.
